New Business

Ms. Peggy Lucero addressed the Board and inquired about the complaint process with the Surveyors Board. Chairman Frazier and members of the committee shared an overview of the complaint review process with Ms. Lucero.

Fee Increase Vote

Mr. Venuti reported that the comment period for fee increases has ended, and the Board should now vote to approve these increases.

Motion (II) was made by Mr. Orisich, seconded by Ms. Rollins, to approve the proposed fee increases with a majority of the members in favor, and one member opposed.

Executive Director's Report

Mr. Thomas notified the members of the Board of the Governor's appointment of Mr. T.J. Frazier as Board Chair of the Board for Professional Land Surveyors. He thanked Mr. Mettee for his years of service on this Board and his dedication to promoting the profession in Maryland. Mr. Thomas reminded the Board members that the annual ethics filing is due on April 31, 2024. The National Council of Examiners for Engineering and Surveying (NCEES) has opened nominations for funded delegates for the annual NCEES meeting in Chicago, IL; taking place from August 14-17, 2024. He continued to report that the State-Specific exams will be hosted April 22-23, 2024, at the State Building at 1100 N. Eutaw St., Baltimore, MD.

Board Counsel Report

Mr. Venuti reported to the Board that the hearing for the Board's sunset extension will held on Friday, March 8, 2024. In addition, the Maryland Apprenticeships in Licensed Occupations Act will not move forward.

Maryland Society of Surveyors (MSS)

Mr. Haynie reported the following:

- The Society has prepared a list of candidates to be presented to the Governor's office for consideration for Mr. Orisich's seat once his term ends in June 2024.
- MSS is currently making changes and updating its by-laws, specifically the Young Surveyors' program.
- A House Bill was introduced to impose a sales tax for professional services, including surveying. MSS intends to send a "no vote" for the Bill.

Review of Applications

Ms. Nebre stated review of applications is ongoing.

Motion (III) was made by Mr. Orisich, seconded by Ms. Rollins, and unanimously carried to enter Executive Session at 12:18 p.m. **This session was permitted to be closed pursuant to General Provisions Article, Annotated Code of Maryland, §3-305(b) (7)**.
