# Quorum Announced and Meeting Called to Order

A quorum was announced by Chair Trai Dagucon-Hunt and the meeting was called to order at 10:01 a.m.

# Approval of Agenda

Chair, Ms. Trai Dagucon-Hunt asked for a motion to approve the agenda Ms. Shanay Dudley made a motion to approve the agenda, seconded by Ms. April Kenney and the agenda was unanimously approved.

## Approval of August 7, 2023 Minutes

The minutes of the August 7, 2023, meeting were reviewed by the Board. Chair, Trai Dagucon-Hunt asked for a motion to approve the minutes. A motion was made by Ms. Shanay Dudley to approve the minutes, seconded by Ms. April Kenney and the motion unanimously passed.

### **New Business**

#### A. APPRENTICE RESTART

Crystal Ngo requested the Board's permission to restart her Limited Nail Technician apprenticeship. The Board denied the request because she already completed her apprenticeship and is eligible to sit for the exam. However, the Board noted that Ms. Ngo was free to undertake her own preparation for the exam if she believes she is not ready. Board Administrator, Mrs. Natika Wallace will send Ms. Ngo a qualification letter to allow Ms. Ngo to schedule the exam.

#### **B. SCHOOLS ON WEBSITE**

Executive Director, Ms. Nicole Fletcher spoke about adding a list of accredited school to the website for people who are looking for that information. MHEC already has an updated list on their website, so the Board will post a link to the MHEC list.

#### **Old Business**

#### A. SERVICE ANIMALS VS EMOTIONAL SUPPORT ANIMALS

Executive Director, Ms. Nicole Fletcher spoke about the difference between service animals and emotional support animals. A service animal is legally defined in Human Services Article, §7-701, Annotated Code of Maryland, as a guide dog, signal dog, or other animal individually trained to do work or perform tasks for the benefit of an individual with a disability. Animals whose sole function is to provide comfort or emotional support do not qualify as service animals under the ADA or in Maryland law.

#### **B. TRANSCRIPT CATEGORY EXAMINATION CHANGE**

Executive Director Ms. Nicole Fletcher spoke about candidates who have finished the hours for one program but want to sit for another one. The cosmetologist and hairstylist programs are the only programs that are sufficiently similar for that to be allowed.

#### C. <u>LEGISLATIVE UPDATES</u>

Executive Director Ms. Nicole Fletcher mentioned active duty military service member family members will receive a certification letter that will allow them to have a MD license for as long as their family member is on active duty in the state of MD. If the person is moving permanently to MD they must apply by reciprocity or by sitting for the exam. Mr. Sid Saab from MD Esthetician Alliance spoke in reference to regulations for estheticians. The board decided that Nicole and Kenneth will draft information to be presented to the Commissioner so that it can be given to the Secretary Office for approval. Executive Director Ms. Nicole Fletcher also mentioned that the continuing education committee meets once a month.

#### D. CURRICULUM APPROVAL

Executive Director Ms. Nicole Fletcher noted that Green Goal Beauty School located in Baltimore, MD was approved on August 23, 2023.
