CONSENT ORDER AND SETTLEMENT AGREEMENT

This matter comes before the Maryland Real Estate Commission (“Commission”) as the result of a complaint filed by Laurie Ann Carpenter (“Complainant”). Based on the complaint and an investigation, the Commission issued a Statement of Charges and Order for Hearing against the Respondent, Jasmine A. Devaraj, a real estate salesperson affiliated with Nitro Realty, license registration number 05-659138 (“Respondent”) and referred the matter to the Office of Administrative Hearings (“OAH”). The OAH scheduled a hearing for February 28, 2024. To resolve this matter without a formal hearing, the Commission and the Respondent have agreed to enter into this Consent Order and Settlement Agreement to provide for the imposition of disciplinary measures that are fair, equitable, and consistent with the best interest of the people of the State of Maryland.

The Commission and the Respondent agree and stipulate as follows:

1. At all times relevant to the matters set forth in this Consent Order and Settlement Agreement, the Commission has had jurisdiction over the subject matter and the Respondent.
2. The Commission licenses the Respondent as a real estate salesperson with Nitro Realty, license registration number 05-659138.
3. The Complainant, Laurie Ann Carpenter, listed her home, 624 Scott Street, Baltimore, Maryland (“property”) for sale.
4. The Respondent, acting as a buyer’s agent for the son of her husband’s co-worker (“prospective buyer”), scheduled an appointment to show the property to the prospective buyer on March 31, 2021, between 6:00 pm and 6:30 pm.
5. Although the Commission does not license the Respondent’s husband in any capacity, the Respondent provided the lockbox code for the Complainant’s property to her husband.
6. On March 30, 2021, at approximately 6:00 pm (the day before the scheduled appointment), using the lockbox code the Respondent had provided to him, Respondent’s

husband entered the Complainant's property with a prospective buyer to show the prospective buyer the property.

7. The Complainant was in the property alone when Respondent's husband and the prospective buyer entered the property.

8. The Respondent admits that by providing the lockbox code to the Complainant's property to her husband, who is not a licensed as a real estate professional, she violated Md. Code Ann., Business Occupations and Professions Article ("BOP"), 17-322(b)(25), which provides:

**§17-322 Denials, reprimands, suspensions, revocations, and penalties--
Grounds.**

(b) *Grounds:* Subject to the hearing provisions of §17-324 of this subtitle, the Commission may deny a license to any applicant, reprimand any licensee, or suspend or revoke a license if the applicant or licensee:

(25) engages in conduct that demonstrates bad faith, incompetency, or untrustworthiness or that constitutes dishonest, fraudulent or improper dealing;

9. The Respondent consents to the entry of an Order that she has violated BOP §17-17-322(b)(25), agrees to the imposition of a reprimand against her license, registration number, 05-659138, and agrees to pay a civil monetary penalty of one thousand five hundred dollars (\$1,500) within sixty (60) days of the date of the entry of this Consent Order and Settlement Agreement. Should the Respondent fail to pay the civil monetary penalty of one thousand five hundred dollars (\$1,500) within sixty (60) days of the entry of this Consent Order and Settlement Agreement, the Respondent agrees that the Respondent's real estate license registration number 05-659138, and any other real estate licenses that the Respondent holds, shall be automatically suspended, and shall continue to be suspended until such time as payment is made.

10. By entering into the Consent Order and Settlement Agreement, the Respondent expressly waives the right to an administrative hearing before the Office of Administrative Hearings, the making of Findings of Fact and Conclusions of Law by an Administrative Law Judge, all further proceedings before the Commission, and any rights to appeal from this Consent Order.

11. The Commission and the Respondent further agree that the Commission shall withdraw this matter from the Office of Administrative Hearings docket for settlement purposes pursuant to Code of Maryland Regulations 09.01.03.07.

12. The Commission agrees to accept this Consent Order and Settlement Agreement as the full and final resolution of Case No. 518-RE-2021.

BASED ON THESE STIPULATIONS AND AGREEMENTS DESCRIBED ABOVE, IT IS THIS 30 DAY OF APRIL, 2024 BY THE MARYLAND REAL ESTATE COMMISSION:

ORDERED that Respondent has violated Md. Code Ann., Business Occupations and Professions Article, 17-322(b)(25), and it is further,

ORDERED that based on these violations, the Commission imposes a **REPRIMAND** against the Respondent's license registration number 05-659138, and it is further

ORDERED that based on these violations, the Commission imposes a civil penalty of one thousand five hundred dollars (\$1500) to be paid within sixty (60) days of the entry of this Consent Order and Settlement Agreement, and it is further

ORDERED that should the Respondent fail to pay the civil penalty of \$1500 within sixty (60) days of the entry of this Consent Order and Settlement Agreement the Respondent's real estate license registration number 05-659138 and any other real estate licenses that the Respondent holds shall be automatically suspended and shall continue to be suspended until such time as payment is made, and it is further

ORDERED that the Respondent has expressly waived the right to an administrative hearing before the Office of Administrative Hearings, the making of Findings of Fact and Conclusions of Law by an Administrative Law Judge, all further proceedings before the Commission, and any rights to appeal from this Consent Order, and it is further

ORDERED that the Commission's records and publications reflect the violation and penalties imposed on the Respondent.
